### Key Responsibilities

- Financial leadership and strategy, to include working with the small executive team to plan a financially viable medium/long term artistic strategy that meets the Charity's core objectives.
- Day-to-day responsibility for all finance functions income management and cost control, including management of cash, bank relationships, book-keeping, payroll, VAT, gift aid etc.
- Implementation of policies and procedures, controls and delegated authorities to ensure effective and accurate financial management, ensuring that all stakeholders, including volunteers, receive appropriate financial support and guidance.
- Annual budget and quarterly forecasts, in collaboration with the executive team.
- Provision of monthly finance reports to support the executive and Board to include management accounts, cash flow, commentary and performance against key performance indicators.
- Ensure appropriate IT systems and controls in place through management of contract for third party IT support.
- Collaboration with Development team to establish fund-raising strategy and targets and to help manage funding applications.
- Management of annual audit process and preparation of statutory accounts in collaboration with external auditors.
- Ensure compliance with all relevant regulatory bodies, Companies House,

Charities Commission, HMRC etc., to include responsibility for routine reporting.

• Ad hoc financial reporting for quarterly Board meetings.
